*****As per the International Standard, Principle Offence Rule is followed for counting of Crime. The same Principle Offence Rule is applied for IPC & SLL reports. Hence among many offences registered in a single FIR case, only most heinous crime (maximum punishment) will be considered as counting unit. (Kindly refer SOP for the same)
